Position Title: Clerk of Court

The United States Bankruptcy Court for the District of South Carolina is seeking applicants for the position of Clerk of Court. The court currently consists of three judges stationed in Columbia, Charleston, and Spartanburg. Staff is headquartered in Columbia, with divisional offices and limited staff in Charleston and Spartanburg.

The Clerk of Court is a full-time position. The Clerk is appointed by and serves the judges of the court. This is a high-level management position which functions under the direction of the judges and is responsible for the administrative activities of the Clerk's Office and overseeing the performance of the statutory duties of the office.

Examples of duties include:

Consulting with and making recommendations to the judges regarding court policies and procedures.

Preparing and managing an annual budget.

Conducting special studies as directed and preparing statistical and narrative reports.

Working with various governmental agencies on a variety of issues necessary to court activities such as data processing, personnel, procurement, space and facilities, and financial matters.

Working with members of the bar and the public to improve the delivery of court services.

Directing staff responsible for the processing of bankruptcy cases and adversary proceedings, case management functions, courtroom support needs, maintenance of official records in the custody of the court, automation and information technology services, statistical analysis and reporting requirements, procurement, financial operations, internal controls, inventory control, and human resources management.

**QUALIFICATIONS STANDARDS:** Must be a United States citizen or eligible to work in the United States. Must have a minimum of 10 years of progressively responsible administrative experience in public service or business which provides leadership capabilities and a thorough understanding of organizational, procedural, fiscal, and human aspects in managing an organization. At least three of the ten years experience must have been in a position of substantial management responsibility. An attorney who is in the active practice of law in either

the public or private sector may substitute said active practice on a year-for-year basis for the management or administrative experience requirement. Education in a college or university of recognized standing may be substituted for a maximum of three years of the required general experience on the basis of one academic year of education equals nine months of experience. A bachelor's degree from a college or university of recognized standing may be substituted for three years of the required general experience. Preferably such degree should have included courses in law, government, public, business, judicial administration or related fields. A postgraduate degree in public, business or judicial administration from such a college or university may be substituted for one additional year of the required general experience. A degree from an accredited law school may be considered as qualifying for two additional years of the required general experience.

Prospective candidates should have a performance history that demonstrates proven skills in managing limited resources, prioritizing, and problem solving. Strong organizational, written, and verbal communication skills are desired. Excellent academic records, experience in a court environment, a law degree, experience in the practice of law, excellent knowledge of the Bankruptcy Code and Rules, and knowledge of the operation of electronic records systems are also preferred.

**BENEFITS:** All court employees are at-will employees. This is in contrast to executive branch agencies, whose employees are generally in the competitive services. This means that court employees generally are not subject to the many statutory and regulatory provisions that govern the employment of individuals in the executive branch. They are, however, entitled to benefits similar to those given other federal employees, which include paid vacation, paid sick leave, ten federal holidays per year, choice of medical insurance from a variety of plans, group life insurance options, long-term care insurance, pretax contributions for medical costs and dependent care, participation in the Thrift Savings Plan and participation in the Federal Employees Retirement System.
