

CM/ECF Participant's Guide

HEARING PRESETS

February 13, 2026

Description: This Participant's Guide is to be used by all CM/ECF filers. CM/ECF filers may use hearing presets to self-schedule hearings pursuant to SC LBR 9013-4. The CM/ECF hearing presets provide a list of available hearing dates for the assigned judge to ensure self-scheduled matters are added to the hearing calendar.

STEP 1 – When filing a self-scheduled matter in CM/ECF, filers are required to input hearing information after uploading the pleading.

- From the dropdown menu, select the appropriate hearing date for the assigned judge based on case chapter and division, motion type, and noticing period pursuant to SC LBR 9013-4(a)(2)(A).
- Refer to SC LBR 9013-4, including Exhibits A and B thereto, and the [self-scheduling calendars](#) for self-scheduling additional guidance.
