ORDER LIFTING THE AUTOMATIC STAY FOR CONSENSUAL LOSS MITIGATION/MORTGAGE MODIFICATION

______("Debtor(s)") requested an *ex parte* order from this Court authorizing modification of the automatic stay to initiate Loss Mitigation/Mediation with creditor _______ its agents, servicers, successors or assigns ("Creditor") in connection with property located at _______ ("the Property").
